Cambridgeshire Freemasons £100K Support for Local Charities



Twenty-six local charities have received a total of £100k in donations from Cambridgeshire Freemasons, thanks to the generosity of The City and University of Cambridge Masonic Charitable Trust and the Province of Cambridgeshire Charity for Care and Relief, alongside contributions from the Masonic Charitable Foundation. The donations were made at Cambridge's Masonic Hall during an event to celebrate community engagement which also included a guided tour of the building.

Hayley Norfolk, CEO of Homestart Cambridgeshire, who help families in Cambridgeshire with young children by providing a volunteer to visit them in their own homes regularly for friendship and support, expressed gratitude, stating,

Prostate Cancer Testing Event

Sixty Freemasons were tested for prostate cancer at Bateman Street in Cambridge during a special event funded by the Cambridgeshire Charity for Care and Relief. This initiative, organized in conjunction with the men's health charity CHAPS and supported by Cambridge Clinical Laboratory, aims to raise awareness, and promote the early detection of prostate cancer and other health issues affecting men.



With 1 in 8 men are likely to be affected by prostate cancer, particularly those over the age of 50, the importance of early testing cannot be overstated. The event saw significant participation from Cambridgeshire Freemasons, underscoring the critical need for proactive health measures.

The Assistant Provincial Grand Master of Cambridgeshire Masons, Jonathan Lambert, was among those tested. Commenting on the event, he stated, *"It was good to see so many fellow Masons attending the testing event. I hope this will encourage other men to do the same."*

CHAPS, a dedicated men's health charity, focuses on raising awareness and promoting early detection to improve health outcomes. The support from Cambridge Clinical Laboratory ensured the event's success, providing accurate and timely testing for all participants.

Bowling for Charity

Twenty-one Masonic Provinces, similar to Counties, sent 24 teams of bowlers to the beautiful County of Berkshire on Friday 9 August 2024. They were competing for the Masonic Annual Charity Event (MACE) Trophy. This fun bowling event has been running since 2011 and moves around the country. This is the first time Berkshire have ever been the hosts.

The very impressive Desborough Bowling Club in Maidenhead was full of excited banter and accents from every corner of the country, as competitors filled the club. This relatively newly built club opened in 2019; after they were 112 years in another part of Maidenhead!

After being welcomed to the event by Ian Keech (organiser for MACE), Anthony Howlett-Bolton *OBE* Leader of Berkshire's Freemasons, Peter Woods Berkshire Masonic Bowling Association (BMBA) President and Frank Overton Secretary of the BMBA play got underway. The ladies and gentlemen players had plenty to play for. As well as the 4 trophies up for grabs. They would be raising money throughout 2024, to support the two nominated charities for the year. In 2024 these are to be, the Berkshire Panto Project, a Berkshire-based event helping children who might not otherwise see a Pantomime to do so. The Panto Project has been arranged every year since 2005, with only Covid causing a break. Lastly, Action for Children, a national charity supporting children and young people across the UK.

Halfway through the event we were joined by Tony Allcock *OBE*, Chief Executive of Bowls England and Russell Race, Past Deputy Grand Master of Metropolitan Grand Lodge. Whose original support for the event set it on this 14 year-long fund and friend-making journey. In the 14 years it has been running MACE has raised over £70 thousand pounds for charities. And probably as many new friends for those taking part in this competition.

The new MACE flag that will be flown at the competition going forward was also unveiled at the halfway break. It was hung alongside the Berkshire Masonic Bowling Association flag throughout the day. The artwork now includes a lady bowler on the flag!

Anthony Howlett-Bolton *OBE* said, "*The Panto Project is a very special event arranged annually in Berkshire. The hard work of the organisers all come together to bring a joyous experience to children who otherwise would miss out of the magic of pantomime.*"

Laura English Rose, Senior Fundraising Manager at Action for Children said, "*Thanks for all your generous support. The contribution you are making to Action for Children will help us provide vital funds to services working hard to help children have the safe and happy childhoods they deserve.*"

Action for Children protects and supports vulnerable children and young people by providing practical and emotional care and support, ensuring their voices are heard and campaigning to bring lasting improvements to their lives. With 426 services across the UK, in schools and online, in 2022/23 they helped 765,905 children, young people and families.

The teams played across 8 rinks, with 6 ends played. The number of ends in the second half of the day reduced to 5.

Bro Brown is an exceptional individual, in addition to being a Lodge member he has demonstrated unwavering dedication and commitment to the City of Ely Royal British Legion Branch for over 26 years.

His contributions and selfless acts of service make him a true role model within our community. For more than six years, Mr Brown has held the esteemed position of Branch Standard Bearer, a role he fulfils with the utmost pride and distinction. Additionally, his invaluable experience and expertise have been instrumental in his role as Deputy Chairman for a significant number of years, particularly during a period where he had to support his first wife during her terminal illness. Bro. Brown continued to selflessly devote countless hours to the Poppy Appeal.

Rain or shine, he has stood in the Market Place in Ely, braving adverse weather conditions to collect donations during the annual Poppy Appeal. It is

through his unswerving determination and commitment that he has successfully helped to raise an impressive sum of over £50,000 annually.

Bro. Brown has also served on the County Committee and the Awards sub-committee. His contributions in reviewing Award Applications and providing recommendations have been invaluable. Moreover, Bro Brown's involvement with the Royal British Legion extends beyond his involvement at the City of Ely Branch where he has also represented at County level for over 15 years as a seasoned Standard Bearer.

Early years of competition were met with fierce rivalry and disappointing placements but through practice, dedication and positive mental application Tom became the Deputy County Standard Bearer before winning the highly prestigious title of County Standard Bearer in 2018. Furthermore, he has attended numerous events, including the 90th-anniversary commemoration of the Battle of Ypres alongside over 2500 other Standard Bearers and wreath layers and at the Annual act of Remembrance at the Royal Albert Hall in 2023, further testament to his commitment to honouring the sacrifices of those who came before us.

He is also holding the position of the National Standard Bearer for the Parachute Regiment and has represented the organisation at overseas commemorations at Arnhem and during D- Day Commemorations for many years.

Bro. Brown's tireless efforts have not been confined solely to the Legion; he has generously volunteered his time at the Airborne Museum, a division of the Imperial War Museum at Duxford. Guiding and assisting tour groups through this historic establishment, Tom has showcased his dedication to preserving and educating others about our military history.

Tom's commitment to the Royal British Legion, Parachute Regiment and other organisations proves his exemplary service is beyond reproach. He serves as an inspiration to all who have the privilege of knowing him. His selflessness and willingness to put the needs of the Legion and its beneficiaries above his own reflect the true essence of the Legion's motto, "Service not Self." Whether it is through his involvement in Branch or County committees, his role as a Standard Bearer, or his dedication to the Poppy Appeal, Tom consistently goes above and beyond, demonstrating an unwavering commitment to serving others.

Gift Aid – Charitable Giving

Dear Brethren,

Welcome to the first of what will be a series of helpful tips from the CMBA to assist you in making your charitable giving as effective as possible, and we're starting with one of the most commonly misunderstood ... Gift Aid envelopes!



Introducing ... make it count!

Charitable giving the smarter way

Our Festival 2023 was a huge success and will go a long way in assisting the Masonic Charitable Foundation (MCF) in the great work it does in improving thousands of lives every year across England and Wales. Now that the Festival has ended, our focus returns to supporting our local community through our Provincial charities, the **Cambridgeshire Masonic Benevolent Association** (CMBA) and **Care & Relief**.

Who are they and what do they do?

The role of the CMBA is to raise funds for, promote, and support, Masonic Charities, The Cambridgeshire TLC scheme, and other charities endorsed by Provincial Grand Lodge. **Care & Relief** dispenses funds for the benefit of poor and distressed masons of the Province of Cambridgeshire, Masonic Charities, and for other registered charitable institutions, societies or objects. Basically, outside of Festival, the CMBA raises charitable funds and Care & Relief distributes them where they are needed.

What's "make it count!"?

The CMBA also provides support to Charity Stewards in Cambridgeshire with effective fundraising tools, making sure that every mason in the Province is getting the most out of their donation. Understanding how masonic fundraising works allows you to really make a difference with your donation, which is why we are introducing 'smarter giving' tips to help you make *your* donation count!

Smarter giving tip #1 – Completing a Gift Aid envelope correctly

Did you know? ... Gift Aid envelopes are used to collect donations which are eligible to attract an additional 25% benefit for a Registered Charity by claiming back the basic-rate tax you have already paid. This is a Government approved scheme and is administered by HMRC. For more information see <https://www.gov.uk/claim-gift-aid>

Gift Aid – A simple process with government support to benefit registered charities!

For every £1 donation, the MCF will receive £0.25 from HMRC. So, for a Lodge with a qualifying Gift Aid collection of £200, HMRC will give £50 to the MCF which then allocates the funds to the Lodge total in the CMBA Relief Chest. This means a £200 collection becomes £250 available for donation to a Registered Charity chosen by the Lodge! The best part is that there is no admin work required by the Lodge as the support is provided free by the MCF and CMBA.

Did you know? ... The MCF no longer keeps enduring Gift Aid declarations which means that you **must tick a box every time** you complete a Gift Aid envelope slip as this is the only method the MCF uses to demonstrate to HMRC that your tax status hasn't changed since your last donation.
Note: This means that you can no longer rely on ticking the box "on this donation and in the future" as every future donation will need a box ticked.

Did you know? ... If you do not pay tax (or enough tax), you do not need to complete an envelope ... you can simply make a cash donation as the MCF does not record your donation for honorific purposes outside of Festival.

Did you know? ... It doesn't matter whether the Relief Chest No. field on your Gift Aid envelope slip is blank or has an old number (like FEST2023 or E0109) as your Charity Steward or Treasurer submits all the slips together with the one form indicating the Relief Chest (CMBA) which is to receive the donations and Gift Aid benefit.

Did you know? ... If you are using Gift Aid envelopes in a Chapter and don't put the letter 'C' in front of the Chapter number then the donation will be credited (for honorific purposes) to the Lodge with the same number by default, so it's good practice to always add a letter (C = Chapter or L = Lodge) in front of the Lodge or Chapter number e.g. L4334 or C4334. *Note: You should always enter your Lodge or Chapter number, not the number of the Lodge or Chapter you are visiting.*

From Gift Aid envelope to Cheque Presentation ...How does it work?

Step 1. Once the Gift Aid envelope slip has been completed correctly (see picture), the slip is torn off and inserted into the envelope with the donation and the envelope is sealed.

Step 2. The envelopes are collected by the Charity Steward or Treasurer who then opens them and sends all the Gift Aid envelope slips with a form and donation payment to the MCF Relief Chest office in London.

Step 3. The MCF then applies to HMRC for the applicable Gift Aid benefit. Once the benefit is received, the MCF places the donation payment and Gift Aid benefit into the CMBA Relief Chest and allocates it to the Lodge or Chapter which submitted the donation.

Step 4. When the Lodge or Chapter selects a Registered Charity to receive the donation (which can be part or all of the funds deposited into the CMBA Relief Chest over a period of time), the Charity Steward or Treasurer simply sends an email to the CMBA Secretary with the details of the charity and the amount to be donated. *Note: Gift Aid envelope collections cannot be used for donations to a Non-Registered Charity.*

Step 5. The CMBA Secretary then arranges for a cheque to be sent to either a Lodge or Chapter representative to present to the charity, or directly to the charity itself.

New CMBA Relief Chest

Following the Festival, the CMBA is now operating a new Relief Chest with an easy to remember number - **CMBA**.

The new CMBA Relief Chest is managed by the CMBA Relief Chest Representative (currently the CMBA Secretary) on behalf of all Cambridgeshire Lodges, Chapters and other units.

The new CMBA Relief Chest replaces the old Relief Chests (E0109 and FEST2023) which will remain dormant and should not be used for new donations.

The updated MCF online system means that a Lodge or Chapter can easily arrange a cheque for their selected Registered Charity within a matter of days simply by sending an email to the CMBA - cmba@pglcambs.org.uk.
